Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, to conduct a risk assessment of those hazards and then to further take steps to either eliminate or control each hazard.			
If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.



This will help ensure that workers can perform these tasks safely and efficiently. - Conduct regular risk assessments and review control measures as necessary, taking into account changes in work processes, regulations, or incident reports related to poor lighting, slips, and falls in the loading/unloading area. 			<ul style="list-style-type: none"> - Clearly mark all pinch points on the equipment to serve as a visual reminder for workers and encourage them to remain aware of these hazards when handling equipment. - Regularly inspect all load restraint systems, including straps, chains, and boards, for signs of wear and tear, and replace them as needed to ensure optimal functioning. - Enforce a strict policy against shortcuts or bypassing established procedure, emphasising the importance of adhering to proper protocol for the safety of all team members. - Conduct regular toolbox talks and refresher training to reiterate relevant safety guidelines and discuss new control measures, if necessary. - Implement a buddy system that pairs experienced operators with those who are less knowledgeable, to provide guidance and oversee proper equipment handling techniques. - Encourage employees to report any issues or concerns regarding equipment operation and safety, fostering an open dialogue about enhancing workplace health and safety practices.

The review process should be carried out in consultation with workers (including contractors and subcontractors) who may be affected by the operation of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
